Application on prescribed Form available from the Office of the undersigned (w.e.f. 22th May 2020 to 18th June 2020) are invited from eligible In-service Teachers of Education Department Govt. of H.P. (5 JBT and 5 C&V Category) Teachers one each from different categories as per Govt. of H.P. orders for admission to Two Years B.Ed. Programme (Regular Mode) for the session 2020-2022 so as to reach the office of the undersigned on or before 18th June 2020 till 05PM. (No application will be entertained thereafter under any circumstances)

Eligibility Conditions for In-service Teachers as per NCTE Norms

- a) Minimum continuous service on regular basis of 5 years with either a Bachelor's Degree or Master's Degree or any qualification as per NCTE Norms time to time there to, with at least 50% marks 45% in case of ST/ST/OBC/Physical Handicapped categories from a recognized University established by Law in India.
- b) At the time of selection, candidates passed with B.Sc. (Non-Medical)/Medical/B.A. with Mathematics and B.A. (with Subjects as per Norms) will be given first, second and third preference respectively against JBT Category.
- c) The application of the desirous In-service Teachers (JBT and C&V Category) must be forwarded and recommended by the Deputy Director of Education (Secondary/Elementary) of the concerned District of Himachal Pradesh in which the teacher is working, with a permission to undergo Two Years B.Ed. Programme (Regular Mode) and verification of Seniority Number in the respective Cadre and date of Joining on regular basis in the Cadre.
- d) Selection of In-service Teacher shall be made on the basis of seniority in the Cadre subject to the fulfilling of seniority in the Cadre, subject to the fulfilling of all eligibility conditions.
- e) No Entrance Test is required for In-service Teachers.
- f) There is No upper age limit for In-service Teachers.
- g) Obtaining Study Leave for Two Years B.Ed. Programme (Regular Mode), 2020-2022 session from Department if any, shall be the sole responsibility of the candidate concerned & the college shall not be responsible for any consequences.
- h) Application Form not supported with the required documents as mentioned in the prospectus is liable to be rejected.

Any regular In-service Teacher (JBT and C&V Category) from the Department of Education Govt. of H.P. seeking admission to Two Years B.Ed.
